6 **FREEDOM OF THE CITY - YOLONDA ANNE CULLIS HENSON**

RESOLVED that, in pursuance of its powers under Section 249 of the Local Government Act 1972, the Council do confer on Mrs Yolonda Anne Cullis Henson Freedom of the City Status in recognition of her eminent service to the City of Exeter as a City Councillor for thirty two years, during which time she keenly supported and promoted the interests of the City.

She has been a member of the Exeter Harriers Athletics Club since 1987 and has been the 5,000m national champion on no less than 6 occasions.”
