# 1. What is the report about?

1.1 An application has been received from Gary Williams trading as Camper Coffee for the GRANT of a new premises licence. Camper Coffee is an upmarket cocktail bar which is located in the McCoy's Arcade in Fore Street, Exeter. The applicant has applied for the sale of alcohol (on and off sales) from 0700 to 2300 Monday to Sunday inclusive and for live and recorded music 1600 – 2300 Monday to Sunday inclusive (indoors only). The application and plans are attached.

# 2. Are there any representations?

2.1 Representations have been received from local business' and other interested parties. Two objections to the application have been received and nine positive representations. Redacted versions of the representations are attached. No representations have been received from a Responsible Authority.

#### 3. Report details:

- 3.1 The application was advertised on the premises and in the local newspaper in line with above legislation. During the consultation period Environmental Health had some concerns regarding possible noise nuisance issues that may arise at the premises. As a result of this Environmental Health proposed the following conditions to be added to the licence. Gary Williams has agreed to the proposed conditions. The proposed conditions are as follows:
  - 1 There shall be no music or amplification of sound outside the premises building after 21.30.
  - The performance of live music shall be restricted to 2 sessions per week.
  - 3 Glass bottles shall not be deposited in any skip, bin or other container located outside the premises building except between 0800 and 2000.

- The licensee shall ensure that a telephone number for contacting the licensee or a nominated person during licensable activities is made publicly available.

  Appropriate action shall be taken to investigate any complaint made.
- 3.2 A letter from the freeholders (South West Land) Limited of McCoys Arcade was received on 16 March 2016 in response to an objection from the owner of Mansons Guitars. The letter is attached as additional information.

# 4. What are the legal aspects?

- 4.1 The Council's constitution requires that all applications for Premises Licences that receive relevant representations shall be determined by a Licensing Sub-Committee.
- 4.2 The Licensing Sub-Committee are required to have regard to the Statement of Licensing Policy which states in part (paragraph 2.8) that in determining a licence application the Licensing Authority will consider each application on its merits. Licence conditions will be tailored to the individual application and only those appropriate to meet the licensing objectives will be imposed.
- 4.3 The Licensing Sub-Committee are required to have regard to the Official Guidance issued under section 182 of the Licensing Act 2003 revised March 2015 is relevant. The official guidance relating to crime and disorder and the prevention of public nuisance to which this committee must have regard, is included in the Yellow Committee hand books.
- 4.4 The Licensing Sub-Committee must have regard to the relevant representations made; the evidence provided in relation to the premises from the parties involved and the evidence it hears, in reaching its decision.
  - 4.5 The Licensing Sub-Committee, having regard to the representation, must take such of the following steps, if any, as it considers appropriate for the promotion of the licensing objectives.
  - to grant the licence subject to any conditions consistent with the Operating Schedule of the application modified to such extent is appropriate for the promotion of the licensing objectives and any mandatory conditions;
  - ii) to exclude a licensable activity from the licence;
  - iii) to refuse to specify a person in the licence as the Designated Premises Supervisor; or
  - iv) to reject the application.

#### 5. Recommendations:

5.1 The Licensing Sub-Committee are required to identify what steps, if any, need to be taken to determine the application.

If, however, the licence also authorises the use of the premises for the supply of alcohol or the provision of late night refreshment, a fee will be required.

Schools and sixth form colleges are exempt from the fees associated with the authorisation of regulated entertainment where the entertainment is provided by and at the school or college and for the purposes of the school or college.





Ref: Application by Gary Williams for a new premises licence at McCoy's Arcade, 22 Fore Street, Exeter, EX4 3AN for Camper Coffee Co.

I am writing to provide representation for Spectrum Housing Group Flats, 1-10, 134 Fore Street, Exeter, EX4 3AN.

I am requesting that the application for the new premises licence, be refused.

The grounds for this request are as follows:

The flats at 134 Fore Street are situated on the level above and adjacent to the McCoy's Arcade. They are occupied by families who already experience a high level of disturbance in the neighbourhood. This would be further exacerbated if the Licence was granted, Noise travels very easily through the arcade and I am informed that current building work at the address has already generated complaints from the tenants. As far as I am aware, no consideration has been shown for those living in close proximity and no information provided to Spectrum that building work was to commence and likely to cause disturbance.

The tenants at these flats are already experiencing a high degree of anti social behaviour and criminal activity through people accessing the block via a communal access way off Bartholomew Street. The police have been called recently for an attempted break-in and vandalism to the flats. We also have problems with dumping of rubbish and fly tipping in the area and have been contacted by Environmental Health concerning this.

I believe that a new premises licence at this location will substantially increase the noise and disturbance experienced by the tenants of the flats. Also this will further increase problems of litter and anti social behaviour which is currently a problem in the neighbourhood. I am therefore submitting this request, on behalf of Spectrum Housing Group, that the application be refused.

I am writing in regard to a licence application at McCoys Arcade, 22 Fore st, Exeter. EX4 3AN.

Gary Williams of Camper Coffee has applied for the right to sell alcohol between the hours of 07:00-23:00 and for live music at the same times 7 days a week.

I strongly object to these requests as a retailer in this arcade for the last 13 years, for the following reasons:

We have had to install locks on the two toilet doors (for use by arcade retailers and their customers exclusively) to prevent drug users wandering in from the street and using the toilets and leaving drug paraphernalia and hypodermic syringes in these. The Arcade is regularly the scene of drug dealing and this area of Fore st has recently been under scrutiny by the police with regard to anti-social disorder in connection to the legal high shop just adjacent to it.

We, as musical instrument retailers, have received complaints from the flats above (Signpost Housing) with regard to noise nuisance from guitar playing during our working hours (9:00-5:30 Monday – Saturday)) despite our sound proofing expenditure to prevent this. Historically every evening event that has been held in the arcade by the previous licence holder (McCoys) was complained about by pyjama wearing neighbours as there is no sound proofing in the arcade or cafe area. These flats above are family houses with young children.

I also question how many licensed evening premises Fore st needs? I feel there are enough already. I noticed many broken shop front windows in the Fore st area on Monday morning this week – after the usual Fore st, alcohol fuelled weekend.
