1. What is the report about?

1.1 Two separate applications have been received from residents of Wonford Street, seeking a review of the Club Premises Licence held by Heavitree & Wonford United Services Club. The applicants have agreed that both applications are to be heard as one. The application for review has been advertised and circulated as required by the legislation. A copy of the notice of the review is attached as Appendix A to this report.

2. Are there any representations?

- 2.1 The legislation requires that any representations in relation to a review must be submitted to the Licensing Authority no later than the 28th day after receipt of the review application. The 28 day period beginning the day after receipt of the application. The last date for representation being the 5th September 2022.
- 2.2 Two applications for review have been received from residents as stated above, the residents reside within the vicinity of the premises. The applications for review are attached as Appendix B and C to this report.
- 2.3 A further representation was received from a local resident on the 28th August and the same resident made further representation on the 4th September. This representation is attached as Appendix D to this report.
- 2.4 Representations have been received from the Devon and Somerset Fire and Rescue Service in their capacity as a Responsible Authority. This is attached as Appendix E to this report.
- 2.5 Representations have also been received from Devon and Cornwall Police in their capacity as a Responsible Authority. This is attached as Appendix F to this report.

2.6 Representations have also been received from Simon Ruddy the Principal Environmental Health Officer for Business regulation at Exeter City Council. His representation is attached as Appendix G to this report. Mr Ruddy has produced a detailed statement of his involvement with the premises and this is attached as Appendix H to this report. The statement references a number of exhibits as SR1 to SR10. Exhibits SR1 to SR10 are appended to this report.

3. Report details:

- 3.1 The applications from the residents referenced all four licensing objectives and were received on 8th August 2022. The grounds for the review are given as follows:
 - Very loud music.
 - Drunk people in charge of minors.
 - Serving of drunks.
 - Anti-social behaviour outside.
 - Building unfit for purpose that is being used for (i.e. Disco's/Nightclub).
 - Staff unable to control customers.
 - Persons in charge (or claiming to be) drunk.
 - Noise and disorder.
 - Nuisance to the public.
 - Breaches of health and safety law.
 - Offensive language.
 - Smoking close to my premises.
 - Prevention of and protection of children from harm.
- 3.2 The representation received from the local resident references a number of noise disturbance episodes alleged to have originated from the licenced premises and as such concerns the licensing objective of public nuisance.
- 3.3 The representation from the Devon and Cornwall Fire and Rescue Service relates to the objective of public safety and references a number of failings in relation to fire safety at the premise following an inspection on the 5th August 2022.
- 3.4 The representation from Devon and Cornwall Police relates to the objectives of prevention of crime and disorder and public nuisance.
- 3.5 The representation from Simon Ruddy relates to the objective of public nuisance and references a number of noise disturbance episodes from the premises.

4. Legal and Policy Considerations:

- 4.1 The Licensing Sub-Committee are required to have regard to the Statement of Licensing Policy which states in part (paragraph 2.8) that in determining a licence application the Licensing Authority will consider each application on its merits. Licence conditions will be tailored to the individual application and only those appropriate to meet the licensing objectives will be imposed.
- 4.2 The Licensing Sub-Committee are required to have regard to the Official Guidance issued under section 182 of the Licensing Act 2003 revised April

2018. An electronic copy of the official guidance has been provided to each member of the Licensing Sub-Committee.

- 4.3 The Licensing Sub-Committee must have regard to the relevant representation made; the evidence provided in relation to the premises from the parties involved and the evidence it hears, in reaching its decision.
- 4.4 The Licensing Sub-Committee, having regard to the representation, must take such of the following steps, if any, as it considers appropriate for the promotion of the licensing objectives and either modify conditions by altering, omitting or adding them; exclude a licensable activity; suspend the licence for a maximum of three months or revoke the licence.

5. Recommendations:

5.1 The Licensing Sub-Committee are required to identify what steps, if any, need to be taken to determine the application.



I've said my piece below (did mean to write & "even that pales in significance to this").

If Social Clubs are set up for the Community, this is definitely not benefiting us - it is so horrendous that everyone in the immediate area's "health & wellbeing "is undoubtedly being affected.

I hope the Council will take into consideration that we would like to see this area as improving and not be subjected to inconsiderate persons who appear to 'have little or no regard for their social responsibilities and certainly not for their community. There is a Pub up the road, maybe allowing that to thrive, especially when many are going out of business, by not competing with cheap booze from a Social Club would be worth taking into consideration.

I hope this will be addressed at your meeting.

I have telephoned & complained following excessive noise from this Club before. I know a neighbour has also contacted you in the last month or so, & probably more have I'm sure. It has been a bit quieter from the music side of things, since then, however, occasionally a lot of noise after 11 pm closing, the other night a huge fight & foul language argument until 12.30. My son went down to ask them to be quiet & someone else yelled "will you just go home". They did eventually!

Then we have the bottles being emptied into the bins after closing time..... that is ongoing. People do get up early to go to work!!

But today we were back to LOUD, LOUD music, PA System from 2 pm. This is just unacceptable! I am a up at the hospital & I am sick of not being able to enjoy my home & garden when I am off. I have lived in my house since 1998 & although I won't deny there has been the occasional leery, drunken fights at full volume, this noise pales in significance. And today only 1 door towards the back was open, can you imagine what it's like when they open the front too.

Please can you explain what has changed with licensing of this place? In the 24 years I have lived here I have never known anything like this.

I have recorded it, should you wish to come round & listen. I look forward to hearing back from you with an action plan.

Hi Nigel,

For your information we carried out a fire safety inspection at the premises on the 5 August 2022. The fire safety issues raised with the responsible person were as follows:

- No fire risk assessment for the premises was available at the time of inspection.
- Storage on the means of escape (external path).
- Fire resisting doors must be effectively self-closing and in good repair.
- The responsible person should know the maximum safe occupancy number for the premises and ensure that the premises do not become overcrowded.
- The responsible person must ensure that fire safety provisions such as fire alarm, escape lighting, firefighting equipment and other fire safety provisions are properly tested and maintained in line with current guidance.

Representation in Respect of Heavitree & Wonford United Service Club – 104 Wonford Street, Exeter, EX25DE

Licensing Objectives: To prevent crime and disorder.

To prevent public nuisance.

On 28/01/2020 23:54:52 the police received log no: DCP – 200128-0903 regarding an incident that occurred on 25/01/2020 at the above premises

A local resident stated there was;

'anti-social behaviour from persons attending the club who were out in the street. Many youths were drinking, and some were smoking cannabis. They were so loud that we could not hear our TV. The swearing was not acceptable in a public place. I went out to have words with them but was met with a lot of verbal garbage, later my wife told them to be quiet and had the same reception. The club have no control over what goes on when they have these gatherings. I could not get through on 101 so gave up. Surely, they have to take some control as a club in a residential area'

PCSO contacted the reporting person who informed him that although the club is generally run ok there are frequent parties of teenagers who cause disorder.

The previous Licensing Officer (LO) from Devon and Cornwall Police arranged and held a meeting with PCSO and the then Club secretary are the on 26/02/2020 at 10:00 hrs held at Heavitree Rd Police Station. At the meeting it transpired they had been holding functions for anybody looking for a place to use inc 18th and 21st birthday parties as well as wakes including non-members. It also became clear they had no knowledge of the Licensing Objectives and the club was not being operated in good faith or according to the legislation regarding Club certificates.

The LO advised Mr **this** this can no longer happen. They could explore applying for a premises licence or if they have events to apply for a Temporary Event Notice.

He asked for an action plan within 14 days with things for them to consider.

Challenge 25

New set of bar rules, incident book etc'

13/03/2020 - Mr was going to send the requested plan as soon as was able to take steps and actions required.

03/06/2020 - Due to the COVID 19 restrictions this item was closed due to the likely hood of the premises being closed for the foreseeable future.

 $14/04/2022\,$ - Email received from Environmental Health regarding noise issues at premises with events being held frequently which often went on past midnight

Since mid-April we've been receiving complaints from local residents about noise and antisocial behaviour at Heavitree and Wonford United Services Club, 104 Wonford Street. There are now five complainants, all of whom are close neighbours (see attached map). The general consensus is that the club is being run more like a pub, with regular live music, disco & karaoke, particularly on Friday and Saturday evening and Sunday afternoons. The complainants mention noise being an issue because of windows and doors left open; they also complain about noise from members outside the club, smoking, shouting, arguing etc. One of the complainants alleges a member of staff has been verbally abusive to her partner and talks of another incident where a neighbour was 'assaulted' (no more information on this). A couple of complainants claim to have spoken to the club about the issues without any resolution, one allegedly being told that they 'shouldn't have moved next to a club'. All anecdotal, this, of course.

I've received log sheets from one complainant who noted loud music on five occasions in June (all of which were within the clubs' licensing hours but often went on all evening until 23:30). There was a live band on the afternoon of Friday 26th June which two complainants said was very loud. A second complainant is particularly upset about the situation; I've shown her how to use the Noise App to record future events and given advice about licensing reviews. This complainant claims to have called 101 on Sunday 17th July to report anti-social behaviour (but claims to have been left on hold and not left a report).

A check on the club's Facebook page showed:

- 'Live music from Claire Bell' on Friday 8th July, 8pm. It was advertised as *free entry*; it's not clear whether this was for club members and guests only.
- The same singer appears (with karaoke) advertised on the afternoon of Sunday 13th July. Again, Facebook says *free entry to all, please share*.
- Sunday bingo 7pm come and support your local club. Use it or lose it.
- Friday night kids disco during summer holidays; £1 per child.
- 'Jai Rocks the 70s' live music, Friday 2nd September 20:00 (same band on 26th June)
- 'Abba tribute coming soon'
- 16th July 'weekend offer all Cactus Jack shots £1 each or 2 for £1.50. Help us get rid of them'

04/08/2022 Spoke with Mike Finn who is the last known club secretary, he no longer holds this post and has given me the name of Mike Collins who has taken over the position. Mr

Collins is under the impression they are able to charge £3 to members of the public which gives them temporary membership to live music when held, this does not meet the criteria of having a 48hr gap between a candidate for membership applying and then gaining the privileges of membership. (Section 62 Licensing Act 2003)

As of 19/08/2022 The premises are continuing to advertise live music and tribute acts at £3 for **non members**.

A date of 09/08/2022 was originally arranged to meet with Mr Collins to discuss the way the premises are being run. This meeting was postponed until 16/08/2022 which was then cancelled due review.

It is clear that there have been issues at these premises from as far back as January 2020, had it not been for the Pandemic and the closure of the club during lockdown it is probable that the Police would have taken action before.

With regards to the more recent problems the police had commenced our normal practice of a stepped approach to addressing the problems, this can be seen by the fact we had a meeting arranged with the club secretary prior to this review being submitted by local residents.

It would appear to the police that these premises are being run as if they were a pub with a premises licence as opposed to a premises with the benefit of a Club Premises Certificate.

Non members appear to being allowed admittance and allowed the privileges of membership in a way not in accordance with the Licensing Act, which puts into question the clubs "Qualifying Club" status.

It would appear that the majority of complaints are of noise coming from the premises, with the additional issue of persons congregating outside.

There should not be anyone outside with open containers of alcohol as this is not allowed due to the mandatory condition on a club premises certificate.

I will leave the issue of the noise from entertainment to the Local Authority Environmental Health department to address.

Should the committee feel that applying additional conditions to the licence I would suggest the following conditions:-

"After 9 pm there shall be no more than 6 persons at a time allowed outside of the premises to smoke"

"There will be no entry/re-entry to the premises after 9pm except for those patrons who have left the premises for the purposes of smoking."

Heavitree and Wonford United Services Club – Licensing Act Representation, Environmental Health & Community Safety, Exeter City Council

- I am Simon Ruddy, Principal Environmental Health Officer of Exeter City Council's Business Regulation Team. This statement is in support of my representation relating to a review of the Club Premises Certificate of Heavitree and Wonford United Services Club, Wonford Street Exeter; it summarises complaints received by Exeter City Council's Environmental Health & Community Safety Service regarding alleged statutory noise and public nuisance issues at the Club from April 2022 onwards.
- 2. On **Monday 25 April 2022**, Environmental Health and Community Safety's support team received a call from a resident of Amersham Court regarding late night music at weekends from Heavitree & Wonford United Services Club. The complainant alleged that he was disturbed by music as late as midnight and that the situation was unacceptable, particularly given that Amersham Court consists of sheltered accommodation for the elderly.
- 3. I sent a standard noise complaint letter to the manager of the Club, dated **29 April 2022**, setting out our approach to investigating alleged statutory noise nuisance, reminding them that the prevention of public nuisance was a licensing objective and asking them to contact me to discuss the matter further. A copy of this letter is attached, ref. SR/1.
- 4. I also sent a letter and some Noise Complaint Record Forms to the complainant, asking him to log any particularly loud events over the next few weeks.
- On Monday 9 May 2022, I received a phone call from the complainant who told me that there were regular – often weekly – discos at the Club, usually on Friday and Saturday night, until 23:30. He said that, most recently he had been disturbed on Friday 6 May, 19:30 until 23:30. The music and the sound of the DJ's were intrusive, he claimed.
- 6. I checked the licensing register; the Club has a premises certificate for live music until 23:00 on a Friday, 23:30 on a Saturday but there was no mention of recorded music. I asked Alan Drake, the then Principal Licensing Officer, to make enquiries as to whether a licence was required for amplified music. Alan told me that it depended on how the disco was organised; he confirmed in an email dated 11 May 2022 that he had written to the Club, reminding them that a club operating under a premises certificate should not be run as a commercial enterprise.
- 7. On **Thursday 9 June 2022**, I received a completed Noise Complaint Record Form from the complainant, a copy of which is attached, ref. SR/2. The complainant recorded three occasions when he was kept awake by (his words) *constant loud music*:
 - a. Friday 6 May, 19:30 until 23:35
 - b. Friday 3 June, 20:00 until 23:30
 - c. Saturday 4 June, 19:00 until 23:15
- 8. (Friday 3 June and Saturday 4 June were Jubilee Bank Holiday Weekend dates, which the complainant acknowledged).

- 10. On **Monday 27 June 2022**, the complainant called me to advise that he had been disturbed by loud music on:
 - a. Friday 17 June, 20:00 to 23:30
 - b. Saturday 25 June, 18:00 to 23:10
 - c. Sunday 26 June, 15:15 onwards (he say that he went out; it had stopped on his return)
- 11. He said that there had also been live music on Friday 24 June but this wasn't too loud.
- 12. Also on **Monday 27 June 2022** a second complainant a resident of Wonford Street, called me. She claimed there had been issues with the Club since the lifting of Covid restrictions, including loud music, shouting and general anti-social behaviour in the street. She said there was loud music on the afternoon on Sunday 26 June although a live music event on Friday 24 June was quiet, suggesting that the Club is able to run events without causing a nuisance.
- 13. I advised the complainant that she could use our Noise App to record any future nuisance type behaviour and submit these to us.
- 14. The Club's Facebook page listed the following events:
 - Saturday 7 May 19:30 Karaoke
 - Thursday 2 June 18:00 Disco DK Entertainment Co.
 - Friday 3 June Disco 20:00 80's disco night with Rhys*
 - Sunday 5 June 13:50 Sunday funday bingo with cash prizes, win your drink, family requests with Rhys
 - Friday 10 June 19:00 Fundraiser and raffle
 - Friday 17 June 19:00 Karaoke*
 - Friday 24 20:00 June Old Skool Rox
 - Sunday 26 June 16:00 Jai Rocks (100 years celebration of club)*
 - Friday 8 July 20:00 Claire Bell

(*events that generated complaints)

15. I had still heard nothing from the Club by this stage so called **Wednesday 29 June 2022**. Mr **Second** said that it was the Club's 100th anniversary, so there had been a number of celebratory events in June. He told me the secretary was a **Second** and that he would ask him to call me.

- 16. Also on **Wednesday 29 June 2022** a third complainant another resident of Wonford Street - called to complain about (his words) *loud disco or karaoke music every Friday and Saturday night and all day Sunday*. He claimed that the Club had front and side doors open and that there were smokers outside and *unsupervised shouting and swearing until late at night*.
- 17. I sent this complainant a letter and Noise Record Forms.
- On Friday 1 July 2022 a fourth complainant another resident of Wonford Street- contacted us about noise on the weekend of 24-26 June. I sent this complainant a letter and Noise Record Forms.
- 19. I then sent a second letter, dated 29 June 2022, to **second letter**, the name given to me by as Club Secretary, to advise him of these complaints and, as before, set out our approach to investigating nuisance both statutory and public. I asked Mr **second** to contact me to discuss the matter. A copy of this letter, reference SR/3, is attached.
- 20. To this date, I have received <u>no</u> contact from anybody at the Club.
- 21. On **Monday 18 July 2022**, I received a further phone call from one of the complainants regarding loud music on the evening of Saturday 16 July; the complainant alleged that the Club's doors and windows were open. The following day another one of the complainants emailed to say that loud music on the afternoon of Sunday 17 July prevented him from enjoying his garden; that he had to sit inside with the windows closed, whilst the Club windows were open. The complainant remarked how he thought the Club wasn't being run as a club anymore, that it was, in his opinion, more like a pub.
- 22. On **Tuesday 19 July 2022**, early afternoon, I received a call from one of the complainants advising that there were a number of drinkers outside the club. I walked past the premises at 13:50; there were approximately 20 people standing outside; I could hear general chitchat from the group from my position on the opposite side of the street but there was no music; in my opinion, this did not constitute a statutory noise nuisance or public nuisance.
- 23. On Friday 22 July 2022, a fifth complainant another resident of Wonford Street contacted us about noise from the Club, claiming it was an issue *from Thursday until Sunday*. The complainant was also not happy about the noise made by members leaving the Club. I sent this complainant a letter and Noise Record Forms.
- 24. Also on **Friday 22 July 2022**, at 22:01, one of the complainants uploaded a Noise App recording of live music. The upload stated that the recording was made in the hallway. Loud music (particularly bass) and several people talking can be clearly heard on the recording. A copy of this recording is available ref. SR/4.
- 25. On **Saturday 23 July 2022**, at 22:15, a Noise App recording of live music was uploaded by the same complainant. The upload states that it was recorded in the bedroom and contains the comment *trying to sleep, need to put earplugs in.* What sounds like muffled amplified singing plus general voices (including those that appear to be children's) can be heard. A copy of this recording is available, ref. SR/5.

- 26. A second Noise App recording was recorded at 23:02 on the same night. The upload states that it was recorded in the bedroom and says *people outside club talking loudly trying to sleep*.
- 27. On **Friday 29 July 2022**, at 22:13 a Noise App recording was uploaded from another complainant. The comment with the upload was *I can hear the loud talking and the swearing in the conversation as I'm going to settle in bed*. In the recording, a conversation between two males can be clearly heard. A copy of this recording is available, ref. SR/6.
- 28. On **Saturday 6 August 2022**, at 19:45, a Noise App recording of live music was uploaded from the same complaint who uploaded on 22 and 23 July. The recording, which the app says was made in the hallway, contains muffled bass and persons talking/shouting/screaming (possibly a child screaming). A copy of this recording is available, ref. SR/7.
- 29. Another recording was uploaded at 22:12 on the same evening. The upload states that it was made in the bedroom; muffled bass and a conversation between two males can be heard, with other voices in the background. A copy of this recording is available, ref. SR/8.
- 30. A final recording was made at 23:08. The upload states that the recording was made in the bedroom and contains the comment *after spending an evening with headphones on now trying to sleep hot night but have to have windows closed very loud music and drunk people outside shouting*. Bass can be heard in the recording with the sound of people talking above this. A copy of this recording is available, ref. SR/9.
- 31. On **Saturday 20 August 2022** at 20:10, I cycled past and stopped outside the Club; there were two or three people standing outside by the fence. The front (Wonford Street) door was closed, the side door open. There was no audible music at the time.
- 32. On **Sunday 21 August 2022** at 18:45, I walked past the Club, which was open but quiet. There was nobody outside the Club at the time.
- 33. On **Tuesday 30 August 2022** (after the August Bank Holiday weekend), I received two more complaints from Wonford Street residents about loud music and anti-social behaviour from the Club. One complainant said that there was loud music from 14:00 on 28 August which meant that they were unable to enjoy their home or garden. There were also alleged issues with occasional noise after the club closed at 23:00 and reference to a fight and argument at 00:30 one night.
- 34. The complainant asked if something had happened regarding the licensing of the Club, as they had never known conditions like this in the 24 years of living in Wonford Street.
- 35. Both of these complainants complained about the noise from empty bottles being emptied into bins after closing time.
- 36. In summary since late April, I have received complaints of alleged noise and anti-social behaviour from seven local residents. The Club is surrounded on all sides by residential property and a common complaint relates to the noise of amplified music escaping from

open doors and windows, particularly on Friday and Saturday nights. There is also a second issue around anti-social behaviour from persons standing outside or leaving the premises.

- 37. Wonford Street is predominantly residential, narrow and doubtless has a low background noise level at night so the potential for disturbance is greater than, say, a city-centre location.
- 38. As far as I am aware, the only outside space to the Club is at front and down one side of the building, where it would appear people stand to get fresh air. A Street View image, ref. SR/10 is attached which shows the proximity to nearby residential properties.
- 39. I have received complaints of noise from amplified music on one occasion in May, five in June, four in July and two (to date) in August. I have monitored the Club from Wonford Street on three occasions but have yet to witness the noise myself; however the Noise App recordings made by two of the complainants give a good indication of the disturbance that be caused by both amplified music and people talking/shouting/screaming.
- 40. It is extremely disappointing that, despite two letters and phone calls, nobody from the Club's committee has contacted me to discuss the matter.
- 41. I believe that further public nuisance issues could be mitigated by keeping doors and windows closed whenever amplified music is played; one must be mindful, however, that good ventilation is important when it comes to controlling the risk from Covid a balance needs to be struck so that airflow is not restricted.
- 42. It may also be prudent to consider whether access to the outside area is restricted in some way perhaps a limit to the number of people outside at any given time, particularly later in the evening (say after 21:00).
- 43. Two complainants mentioned noise from the disposal of empty bottles late at night. This activity should be scheduled at a time of day that is not likely to cause noise issues.
- 44. If these simple actions prove ineffective, then specialist sound insulation and other changes to the building structure, design and layout may be required to sufficiently control noise. In this case, the advice of an acoustic consultant is important to ensure that adequate measures are implemented.

I have received a complaint of an alleged noise nuisance caused by loud music being played until midnight at weekends at the above premises.

At this stage I do not have any evidence to support this complaint but am bringing the matter to your attention for you to consider whether or not any remedial action is necessary.

Exeter City Council has a duty to investigate all reports of nuisance. If a statutory nuisance is witnessed and continues unabated we are obliged to take formal action under the provisions of the above legislation. Evidence gathering for such action may involve unannounced personal visits by staff from this Department or the use of remote recording equipment.

You will also be aware that the prevention of public nuisance is one of the key objectives of the Licensing Act; failure to meet this objective can trigger a review of your premises licence.

In our experience this type of problem is best dealt with on an informal basis and therefore your co-operation would be appreciated. Please call me to discuss this using the number above.

Statutory Noise Nuisance

Under the Environmental Protection Act 1990 it is an offence to cause a statutory noise nuisance.

What is a statutory noise nuisance?

Nuisance can be described as an act that causes unreasonable disturbance to the use and enjoyment of one's property (e.g. regular intrusive loud music from an above or nearby property).

It is a common myth that noise levels are controlled by the time of day. Many people believe that they may play loud music all day as long as they turn it down at 11pm. This is totally untrue. There are no set times or levels which determine whether noise is causing a statutory nuisance. Officers must use their professional judgement to decide whether the offending noise is causing an unreasonable disturbance to the use and enjoyment of the complainant's property.

The role of the City Council

Exeter City Council has a statutory obligation to investigate complaints of alleged noise nuisance. If this service receives a complaint we must take reasonable steps to investigate that complaint and if we believe a statutory noise nuisance exists, is likely to occur, or is likely to recur, then we can serve a Noise Abatement Notice. This is a legal document requiring the abatement of the nuisance immediately, or within a specified timescale. We can also outline steps that must be taken so as to assist this abatement.

How do we investigate the complaint?

In most cases officers from our service will try to personally witness the noise or digital noise monitoring and recording equipment may be used to obtain evidence of a noise nuisance.

In all cases of noise nuisance the complainant is required to complete a noise record sheet. This enables them to detail the times and the effects of the alleged noise. Accurate and comprehensive noise records can be used as evidence in the noise investigation and may provide the basis for any subsequent legal proceedings.

The legal implications of causing a noise nuisance

If a statutory noise nuisance is proven then a Noise Abatement Notice will be served. A witnessed contravention of this Notice, by an authorised Council officer, is an offence under the Environmental Protection Act 1990. This will result in an appearance before the Magistrates' Court, where fines of up to £5,000 per offence for domestic premises or an unlimited fine for a commercial premise can be issued. Each witnessed contravention of the Notice can be deemed a separate offence.

In relation to this the City Council also has powers to enter property and seize all equipment capable of amplifying sound. This could mean a stereo system, a radio alarm clock or even a television!

And finally, we don't want to spoil anyone's fun we just want people to think about the noise they may be making and to 'tone it down' if it's disturbing their neighbours. We will take effective action against those people who refuse to do so.

Report of alleged noise nuisance arising from amplified music at Heavitree and Wonford United Services Club, 104 Wonford Street Exeter Devon EX2 5DE

I have received four complaints of alleged noise nuisance from amplified music at Heavitree and Wonford United Services Club. The complaints generally relate to weekend evenings, with music often reported until after 23:00; an event on Sunday 26th June from 3pm was also reported as being particularly loud. The complainants allege that the matter is made worse by the Club's doors being left open during these events.

At this stage I do not have any evidence to support these allegations but am bringing the matter to your attention for you to consider whether or not any remedial action is necessary.

Exeter City Council has a duty to investigate all reports of alleged nuisance. Evidence gathering may involve unannounced personal visits by staff from this Department or the use of remote recording equipment. If the noise is deemed to constitute a statutory nuisance we are obliged to take formal action under the provisions of the above legislation. Failure to comply with an abatement notice served in respect of a statutory nuisance is an offence.

You will also be aware that the prevention of public nuisance is one of the key objectives of the Licensing Act; failure to meet this objective can trigger a review of your club premises certificate.

In our experience this type of problem is best dealt with on an informal basis; therefore your co-operation would be appreciated. Please call me to discuss this on the number above.
