3.1 ENF/11/67 – <u>51 Howell Road, Exeter</u> – Enforcement Notice issue on 12 October 2011 for erection of a single storey rear extension.

- 3.2 The Notice requires the owner to:
 - (a) Remove the single storey rear extension
 - (b) Remove from the property all building materials and rubble arising from compliance with requirement (a)
- 3.3 The Notice comes into effect on 21 November 2011 and gives a period of eight months for compliance.
- 3.4 ENF/11/20 Chunky Monkey, Weircliffe Park, St Andrews Road, Exeter Enforcement Notice issued on 21 October 2011 for the change of use of part of the premises from industrial/workshop purposes to use as a single dwelling, with associated garden area.
- 3.5 The Notice requires the owners to:

- (a) Cease the occupation or use of any part of the premises for residential or domestic purposes
- (b) Permanently remove from the premises all domestic furniture, including all bedroom, bathroom and kitchen facilities, and any other paraphernalia associated with, or facilitating, the residential use of the premises.
- 3.6 The Notice takes effect on 30 November 2011 and gives a period of twelve months for compliance.

- 5.1 ENF/10/23 6 Florida Drive, Exeter Enforcement Notice issued on 6 June 2011 for a change of use of land providing a visual amenity for the public benefit, to land forming part of the private garden of the dwelling.
