# 13 NOTES OF MEETING HELD ON 15 NOVEMBER 2007

The notes of the meeting held on 15<sup>th</sup> November 2007 were agreed as a correct record.

# 14 **PROCESS UPDATE**

Mr. Terry Green provided an update on the process control PLC upgrade which commenced as planned in January 2008. The programme of works is making good progress and is all on target.

A purpose-built IT room situated in the dryer control room has been completed. A new control room is currently being built in the press room from where the Team Leaders will have operational control of the processing plant. It will also be possible to have a visual overview of the plant status from any computer connected to the common network.

The planned replacement of the dryer is unlikely to be ready to install in spring as previously planned. The rotor is ready but the shell is still being manufactured. A bank holiday weekend is needed to install it, so the August bank holiday is the new target date to carry out this switchover.

The new press fume scrubbing system is still in the process of being manufactured and is due to be installed in June 2008 as planned.

## 15 <u>COMPLAINTS RECEIVED SINCE THE LAST MEETING</u>

An updated list of complaints received and the quarterly complaint figures were circulated to members.

The number of complaints received has been exceptionally low; this may be attributable to improvements made in the factory processes. The weather has been similar to previous years.

Improvements made at the factory have had a positive impact on the number of complaints, for example, the improvement of fume extraction from the press room – the air is now significantly cleaner in this department. The new raw material pump system and enclosed pipe work have eliminated input of air pressurising the dryer, and as a result, fume in the dryer room has also greatly improved

Several roofing sheets were lost due to high winds in December and January and emergency repair, followed by permanent repair, was carried out. However, no complaints had been received that were directly attributable to this problem.

Mr John Staddon stated that he had not received any complaints directly from residents. Less complaints have been received from residents in general. Two of the complaints occurred when the No.2 boiler malfunctioned.

## 16 <u>ANY OTHER BUSINESS</u>

Mr Terry Green gave an update following a meeting held in January with Viridor and Cyclerval with regard to the possible supply of steam to the factory from the proposed Energy from Waste (EfW) incinerator. Mr Green reported that the Company remains interested in a suitable proposal but emphasised that discussions remain at a very early stage. The distance from the EfW to the factory is approximately 800 metres.

## 17 <u>DATE OF NEXT MEETING</u>

The next meeting was arranged to be held on Wednesday 8<sup>th</sup> October in Rennes Room, Civic Centre.
