(i) David Follett - Age:19 - Sport/Activity: Wheelchair Badminton

David represented England in the Four Nations Championships this summer and would again be representing England in a forthcoming Four Nations tournament in Ireland. David hoped to continue to be selected for the National team and to compete in international matches in the coming year. He was also intending to take his Level 1 coaching award so that he could put something back into the sport. His coach believed he had the potential to reach the top five in the country and continue his very rapid progress. David was also keen to raise awareness of his sport in the hope that it would eventually become a Paralympic discipline.
