# 1. What is the report about?

1.1 An application attached as Appendix A has been received from the Applicant for the grant of a new premises licence for The Mad Batchers, Unit 1, 25 Manor Road, Exeter. A plan of the premises is attached at Appendix B

# 2. Are there any representations?

2.1 There has been 10 representations received and these are attached at Appendix C. The representations are relevant to the Licensing Objectives the Prevention of Public Nuisance, Public Safety & Protection of Children from Harm

### 3. Report details:

- 3.1 The licence seeks to apply for:
  - Supply of alcohol: Monday to Sunday: 15.00-23.00 Off Sales by home delivery
- The applicant has set out steps it intends to take to promote the Licensing Objectives in the Operating Schedule in the application
- 3.3 The application was advertised on the premises Friday 1 March and in the local newspaper on Thursday 7 March in Express & Echo in accordance with the requirements of the Licensing Act 2003. The end date for representations was 28 March 2019

- 4.2 In determining a licence application the Licensing Sub-Committee will consider each application on its merits.
- 4.3 The Licensing Sub-Committee, having regard to the representations, must take such of the following steps, if any, as it considers appropriate for the promotion of the Licensing Objectives.
  - (a) To grant the licence subject to:
    - i. The conditions consistent with the operating schedule modified to the extent that the authority considers appropriate for the promotion of the Licensing Objectives;
    - ii. The mandatory conditions under sections 19, 20 and 21 of the Act.
  - (b) To exclude from the scope of the licence any of the licensable activities to which the application relates;
  - (c) To refuse to specify a person in the licence as the premises supervisor;
  - (d) To reject the application.

Section 18 (5) of the Act provides that conditions in the operating schedule are modified if any of them is altered or omitted or any new condition is added.

List here steps you will take to promote all four licensing objectives together.

By providing alcohol directly to customer homes it ensures they are in a safe and private location when consuming alcohol. This will help prevent underage drinking and also drinking in public places. This will also help protection of children due to only conducting online payments and not allowing cash sale of product ensuring children will be far less likely to purchase. As well as reducing public nuisance as once an order is placed it will go directly to the customers home reducing the chance of anyone being a public nuisance while ordering alcohol. We will also be working with well established delivery companies such as deliveroo who already have vigarious ID policies in place and ensuring public safety.

### b) The prevention of crime and disorder

By providing alcohol directly to customer homes it ensures they are in a safe and private location when consuming alcohol. This will help prevent underage drinking and also drinking in public places.

### c) Public safety

We are not on a high street location so since this is mainly a delivery service it will ensure customers are likely to remain in their on home and also reduces the chance of drink driving due to the availability of having the product delivered.

## d) The prevention of public nuisance

As we will not be selling to customers directly via the unit it will ensure that clients that have our alcohol product will not be in the public when receiving and consuming our product.

### e) The protection of children from harm

Since we are not selling alcohol directly via the premises this will ensure that no minors are able to purchase alcohol via getting someone older to buy it on their behalf. Since this is mainly online sales it will help that multiple companies will be invoked with the client to help reduce greatly the chance of underage drinking and danger to children.

NOTES ON DEMONSTRATING ENTITLEMENT TO WORK IN THE UK

# Entitlement to work/immigration status for individual applicants and applications from partnerships which are not limited liability partnerships:

A licence may not be held by an individual or an individual in a partnership who is resident in the UK who:

- does not have the right to live and work in the UK; or
- is subject to a condition preventing him or her from doing work relating to the carrying on of a licensable activity.

Any premises licence issued in respect of an application made on or after 6 April 2017 will become invalid if the holder ceases to be entitled to work in the UK.

Applicants must demonstrate that they have an entitlement to work in the UK and are not subject to a condition preventing them from doing work relating to the carrying on of a licensable activity. They do this by providing with this application copies or scanned copies of the following documents (which do not need to be certified).

# Documents which demonstrate entitlement to work in the UK

- An expired or current passport showing the holder, or a person named in the passport as the child of the holder, is A British citizen or a citizen of the UK and Colonies having the right of abode in the UK [please see note below about which sections of the passport to copy].
- An expired or current passport or national identity card showing the holder, or a person named in the passport as the child of the holder, is a national of a European Economic Area country or Switzerland.
- A Registration Certificate or document certifying permanent residence issued by the Home Office to a national of a European Economic Area country or Switzerland.
- A Permanent Residence Card issued by the Home Office to the family member of a national of a European Economic Area country or Switzerland.
- A current Biometric Immigration Document (Biometric Residence Permit) issued by the Home Office to the holder indicating that the person named is allowed to stay indefinitely in the UK, or has no time limit on their stay in the UK.
- A **current** passport endorsed to show that the holder is exempt from immigration control, is allowed to stay indefinitely in the UK, has the right of abode in the UK, or has no time limit on their stay in the UK.
- A current Immigration Status Document issued by the Home Office to the holder with an endorsement indicating that the named person is allowed to stay indefinitely in the UK or has no time limit on their stay in the UK, when produced in combination with an official document giving the person's permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A full birth or adoption certificate issued in the UK which includes the name(s) of at least one of the holder's
  parents or adoptive parents, when produced in combination with an official document giving the person's
  permanent National Insurance number and their name issued by a Government agency or a previous employer.
- A birth or adoption certificate issued in the Channel Islands, the Isle of Man or Ireland when produced in
  combination with an official document giving the person's permanent National Insurance number and their
  name issued by a Government agency or a previous employer.
- A certificate of registration or naturalisation as a British citizen, when produced in combination with an



We are writing to you to strongly object to the new premises licence proposed by Mr Mooney for the above premises. As a young family who have recently moved into Cornwall Street, a very quiet and residential street, we are extremely alarmed at the possibility of the property being licenced to sell and deliver alcohol.

We have the following concerns about a premises licence being granted in our residential street:

# 1. The prevention of crime and disorder

With alcohol being kept on the premises we are concerned about theft and break-ins to the premises from those vulnerable or living with addiction. This is also likely to mean an increase in crime and home break-ins in the area due to the quiet residential nature of the street.

# 2. The prevention of public safety

The application suggests a delivery service running from the premises which naturally means increased traffic along the street and in the area. We are concerned for the safety of children who play and cycle along the street, as well as those more elderly and vulnerable in our neighbourhood.

### 3. The prevention of public nuisance

We are concerned about increased noise, due to the late operating hours (11pm) of Mr Mooney's premises. As well as again increased traffic around school hometime (3pm). With us having small children in the next year this really would be a nuisance to us as a young family.

# 4. The protection of children from home

Due to the immediate proximity to Montgomery Primary School as well as the small children's martial arts club next door to the premises, that a premises would receive an alcohol licence from the city council is extremely alarming.

We moved into Cornwall Street in late October 2019 for the very reasons of it being a safe and quiet street. There are many local shops and pubs in the area where people can purchase alcohol, please do not let this happen in our street.

We are writing to object to this application to supply alcohol from the premises at 25 Manor Road.

As residents of Manor Road we object to giving a license to sell alcohol from a business in what is a residential area, with a neighbouring school and a busy congested road at various times of the day, especially in the evenings as people come home from work.

# Prevention of crime and disorder

A business such as this is not only inappropriate to operate from a residential area but unnecessary as there are several businesses licensed to sell alcohol in nearby Okehampton Road, Cowick Street and Buddle Lane, attracting our share of 'park and street drinkers' to the area.

Storage of alcohol in these premises could well attract burglars and increase opportunist crime in our area.

There are many older residents around here as well as families and we all need to feel safe in an increasingly unsafe world. There have been several break ins and attempted break ins in an area frequented by drug pushers and other unsavoury characters.

### **Public Safety**

With the increase in traffic, to deliver the goods by van or lorry to small roads such as Manor Rd. or Cornwall St. could endanger children and older people, who already use the paths and cross the street often at their peril as the 20 mph limit is frequently ignored. Children and young people going to classes at the Martial Arts centre could find the road even more congested as vans or bikes come and go to collect and deliver orders. In addition it would be reasonable to assume the people working to fulfil the orders and maintain stock will be using vehicles meaning increased traffic and requiring additional parking in the area.

# The prevention of public nuisance.

The atmosphere of this residential area would certainly be changed (adversely affected) by the increase in traffic for deliveries to and from the premises, whether by van, lorry, motor

bike/scooter or bicycle. The streets are already narrowed by the many residents vehicles parking here and of course the evenings are peek time for parking. Increased noise, movement and even delivery people congregating whilst waiting for the orders in the evenings would, for us, constitute a public nuisance.

Whilst not directly applicable to this application for a licence it is pertinent to our concerns that the applicants have stated their intention to start a catering delivery business as well – cooking and delivering from these premises – another potentially big increase in traffic with deliveries of stock, staff working and delivering the orders.

With both alcohol deliveries and food deliveries the public nuisance would be additional busyness, noise and cooking smells.


# The protection of children from harm



# **Protection of Children from Harm**

This is very clearly a built up residential area which adjoins a primary school. One of the pedestrian entrances is in very close proximity to the premises applying for an alcohol licence.

School traffic has always been an issue with pick up at 3pm but since the flats were built opposite 25 Manor Road the traffic throughout the day and particularly in the evening has significantly increased.


### **Public Nuisance / Public Safety**

The increase in traffic has contributed to both the existing parking issues in Manor Road, Landscore Road and Cornwall Street but also causes a substantial amount of noise disturbance, in what was once a quiet residential street. Most evenings it is not even possible to use the turning circle at the end of the road,

opposite 25 Manor Road, as residents use this area for parking. This blocks the road and would be an issue for any emergency vehicle needing to access the school or the flats.

A constant flow of traffic to supply alcohol for home delivery between 15.00 and 23.00 Monday to Sunday will only exacerbate these issues. For these reasons, I think it is highly inappropriate for this type of business to operate from a residential area. I would also add that alcohol is readily available from several local businesses in St Thomas who already open until 11pm.

I would also like to raise concerns regarding the process followed to notify residents of Manor Road about the licensing application. As you will see from the attached photos, the only notification about this application was placed on a building in Cornwall Street; there are no notices in Manor Road.

RE: Objection to application for a new premises licence, Sam Mooney, "The Mad Batchers", Unit 1, 25 Manor Road, Exeter, EX4 1EN

I am writing to firmly object as per The Licensing Act 2003 to the application to supply alcohol from the premises of 25 Manor Road.

### **Protection of Children from Harm**

25 Manor Road is situated amongst a built up residential area which adjoins a primary school. The availability of alcohol is a concern given that the proposed opening hours coincide with children leaving school from 3pm onwards.

### **Public Nuisance / Public Safety**

School traffic has always been an issue with pick up at 3pm but since the flats were built opposite 25 Manor Road, the traffic throughout the day and particularly in the evening has significantly increased, additional traffic at this time will contribute to the existing parking issues in Manor Road, Landscore Road and Cornwall Street which is a nuisance for residents.

A pedestrian entrance for the school is within metres of the premises applying for an alcohol licence, the safety of children entering and exiting the school on foot is cause for concern with additional delivery traffic parking and turning in a tight space.

The increase in traffic also causes a substantial amount of noise disturbance, in what was once a quiet residential street. A constant flow of traffic to supply alcohol for home delivery between 15.00 and 23.00 Monday to Sunday will only exacerbate the noise for residents of Manor Road.

Most evenings it is not even possible to use the turning circle at the end of the road, outside 25 Manor Road, as this area is used for parking. This blocks the road and would be an issue for any emergency vehicle needing to access the school from Manor Road or the flats – Manor Place.

There is not adequate parking or turning space for existing residents so I fail to see where the vehicles used for delivery of alcohol will park whilst loading and unloading and during downtime.

I think it is highly inappropriate for this type of business to operate from a residential area.

Finally, I would like to raise concerns regarding the process followed to notify residents of Manor Road about the licensing application. As you will see from the attached photos, the only notification about this application was placed on a building in Cornwall Street; there are no other notices in Manor Road.

Dear Sir or Madam

As a resident of (EX4 1BU) I am putting in writing why I do not think that it is sensible, reasonable or safe to grant the application that Mr Sam Mooney has made for a premise licence at address, Unit 1, 25 Manor Road, Exeter EX4 1EN. In accordance with the Licensing act of 2003 I would like to state that allowing such an application to go through would be in violation along the following grounds;

- the prevention of crime and disorder (for example drug-related problems, disorder, drunkenness and anti-social behaviour)
- Public safety (the physical safety of people using the venue)
- The prevention of public nuisance (for example noise from music, litter and light pollution)
- The protection of children from harm (including moral, psychological and physical harm)

Cornwall Street and the adjacent areas is not an appropriate site to allow the sale of alcohol regardless of it being off premise. My understanding is that Mr Mooney is looking to run a 'deliveroo type' alcohol service from this location. As a car owner and parking permit holder I have concerns about deliveries blocking our road, possible damage caused to our vehicle by deliveries or by alcohol delivery drivers and about the space needed to run such an operation. As it stands myself and my neighbours often find that we are having to park several streets away as there isn't enough room for the current levels of cars and permit holders.


The current passage way that links Cornwall Street and Manor Road is a useful one, and a lot of people take advantage of it. This is also the case on most weekends where people returning from a late night out will use it as a short cut for their journey. This already brings a certain level of noise, shouting and litter (beer cans and kebab boxes mainly) to our street and I believe that offering an alcohol delivery service will only increase the noise levels and nuisance caused to the public/ residents throughout the week from staff members and their transport.

With a school right next door, as well as a lot of children living in the area, I also have worries about the rubbish and litter that such a business will bring

Finally, and as a license holder, (who has worked in hospitality establishments for 10 years, License number EXE-001129) I have managed at various levels pubs and restaurants around Exeter and know what effect the sale of alcohol has on an area and community. Any establishment that sells alcohol will always bring unwanted attention. This will come in the form of people looking to cause trouble, drunk people trying to collect or place an order and possible drug users. I have serious concerns that allowing such an establishment in the area will have irreversible damaging affects to the community and make living the area extremely unpleasant and unsafe place to live.

I am writing to firmly object as per The Licensing Act 2003 to the application to supply alcohol from the premises of 25 Manor Road.

# **Protection of Children from Harm**

This is very clearly a built up residential area which adjoins a primary school.

School traffic has always been an issue with pick up at 3pm but since the flats were built opposite 25 Manor Road the traffic throughout the day and particularly in the evening has significantly increased.

# **Public Nuisance / Public Safety**

This has contributed to both the existing parking issues in Manor Road, Landscore Road and Cornwall Street but also causes a substantial amount of noise disturbance, in what was once a quiet residential street. Most evenings it is not even possible to use the turning circle at the end of the road, opposite 25 Manor Road, as residents use this area for parking.

A constant flow of traffic to supply alcohol for home delivery between 15.00 and 23.00 Monday to Sunday will only exacerbate these issues. For these reasons, I think it is highly inappropriate for this type of business to operate from a residential area. I would also add that alcohol is readily available from several local businesses in St Thomas who already open until 11pm.

I also feel that due diligence has not been followed in notify residents of Manor rd of this application; I believe clear and obvious notification needs to be placed in the area, the only posters of note are on a building in Cornwall street, which is not even the street or road where the application is being made from, see attached photo's; this to me is an obvious and devious ploy to limit notification of the application.

Please can you confirm receipt of this objection as the closing date for submission is today.
