I write with reference to the proposed new bin storage areas for numbers 2 - 32 Hamlin Gardens, and enclose a petition against them.

I called several times at these and surrounding properties, and those who I found home voiced utter disgust at the very idea of these proposed eye sores. Residents concerns included the positioning, size and appearance of these bin areas. The main fear was of them being inadequate for their intended use which would lead to an over flow of household waste thus encouraging vermin, seagulls, foxes and even possible fly tipping.

You told me during our telephone conversation on 30th May that there were no plans to continue this scheme at other blocks within the Hamlin Gardens estate. Perhaps you could enlighten me and my fellow neighbours how the same fire risk assessment does not apply to them. Furthermore, one resident who has lived here for circa 40 years was not aware of any arson attacks or attempts thereof.





















