Further to our telephone conversation this morning, I've spoken to a contact in SWW's Proactive Team about Friday's odour. She had nothing unusual to report from the works and planned to pay a visit to the pumping station this afternoon. We have received no other complaints for that day. Thinking about it, I was out on Friday evening and ran along Newport Road, Wear Barton Road & Glasshouse Lane at around 20:00 - no odour in that area at the time. I can find historical wind data for Exeter airport online - SW on Friday morning, changing to WNW in the afternoon so (assuming similar conditions in Countess Wear) the wind would have been blowing from the direction of the works (rather than the pumping station) for at least part of the day.

There is a regular SWW Liaison Group where complaints and developments at the works are discussed with SWW, ourselves, the ward Councillor, Environment Agency & residents' representatives so please let me know if these issues continue.

Thank you for your email regarding odour from the sewage works. Waste operations on the site are covered by a permit issued by the Environment Agency, to whom I will pass on your concerns. I am aware of a number of odour complaints about the works from Countess Wear residents over the past week or so; SWW reported a broken scraper on Friday but until that time, I was informed that the site was operating normally. According to the site manager, a new odour control spray system (which produces a fine mist along the perimeter of the site) is due to come into operation this week.

I meet regularly with the ward Councillor, residents' representative, Environment Agency and South West Water to discuss operation of the site and talk about complaints received. Dear Mr Ruddy

Thank you very much for your reply.

I should point out, firstly, that the odour problem from the sewage works is not a recent event. I have been a regular complainer to the Environmental Health Department ever since I moved to Countess Wear, six years ago. The odour problem is evident, winter and summer, although much more noticeable in the summer.

The responses I have received to my complaints follow a now familiar pattern, that is, South West Water provide an excuse, blaming the smell on some piece of equipment that has 'just failed', that they will be replacing in the very near future. On one occasion the blame was placed on a long, warm, dry spell of weather. It would be laughable if it were not such an insult to the intelligence.

A colleague says she attended Countess Wear School forty years ago, and vividly remembers the stench being a frequent problem then.

I would like to know why this has been allowed to continue for so long. Why was a whole estate of residential dwellings built in such close proximity to a sewage works in the first place, and why are new properties continuing to be built in this locality? Is the Environmental Health Department powerless to compel South West Water to comply with regulations, or is it a case of turning a blind eye? You state in your email to me, that prior to last Friday, the sewage works was operating normally. If that is the case, why have there been so many awful stenches coming from the works during the last month, last six months, and the last forty years?

Surely S.W.W. are in breach of the permit issued to them by the Environment Agency?

I was informed some time ago that a Proactive Team was in operation at the site. I decline to take part in a useless exercise of complaining to the organisation about their own misdemeanours, which they are obviously already aware of.

It is worrying, with the increase in new housing locally, that the situation can only get worse and with limited

space available to South West Water to expand its sewage works, that its ability to cope will be stretched even further. Is this included in their Governance?
