

# REPORT TO LICENSING SUB COMMITTEE

## 1. What is the report about?

- 1.1 A premises licence application, attached at Appendix A, has been received by the licensing authority for a new premises licence. A plan of the premises is attached as Appendix B.
- 1.2 The premises is Wine World, 11 Fore Street, Topsham, Exeter, EX3 0HF.

## 2. Are there any representations?

- 2.1 There have been two representations received objecting to the application on the grounds of the prevention of public nuisance, public safety, prevention of crime and disorder and the protection of children from harm.
- 2.2 The representation at Appendix C from an interested party that lives in Topsham.
- 2.3 The representation at Appendix D from an interested party that lives in Topsham.
- 2.6 The last date for receiving representations was 18 May 2023.
- 2.7 No representations have been received from other residents or any of the other responsible authorities.

## 3. Report details:

- 3.1 The application was advertised on the premises and in the local newspaper in line with the above legislation. A copy of the notice that was used in the paper and on the premises is included as Appendix E.
- 3.2 This application seeks to license a retail shop in the main street of Topsham as a local independent wine merchants selling, wines, craft beers, continental beers and spirits for consumption off the premises.

3.3 The applicant has offered a number of conditions as appropriate to promote the Licensing Objectives and these are found within the application.

## **4. Legal and Policy Considerations:**

4.1 The Licensing Sub-Committee are required to have regard to;

- the representations (including supporting information) presented by all the parties; and
- the Official Guidance issued under section 182 of the Licensing Act 2003 revised April 2018; and
- the Licensing Authorities Statement of Licensing Policy which can be viewed here: [Licensing Authorities Statement of Licensing Policy](#)

4.2 In determining a licenced premises application the Licensing Sub-Committee will consider each application on its merits.

4.3 The Licensing Sub-Committee, having regard to the representations, must take such of the following steps, if any, as it considers appropriate for the promotion of the Licensing Objectives.

(a) To grant the licence subject to:

- The conditions consistent with the operating schedule modified to the extent that the authority considers appropriate for the promotion of the Licensing Objectives;
- The mandatory conditions under sections 19, 20 and 21 of the Act.

(b) To exclude from the scope of the licence any of the licensable activities to which the application relates;

(c) To refuse to specify a person in the licence as the premises supervisor;

(d) To reject the application.

4.4 Section 18 (5) of the Act provides that conditions in the operating schedule are modified if any of them is altered or omitted or any new condition is added.

## **5. Recommendations:**

5.1 The Licensing Sub-Committee are required to identify what steps, if any, need to be taken to determine the application having regards to the 4 licensing objectives of;

- Protection of children from harm
- Prevention of public nuisance
- Public safety
- Prevention of crime and disorder
